SECOND AIR DIVISION ASSOCIATION

BY-LAWS

- I. NAME  
The name of this organization shall be the Second Air Division Association.
- II. PURPOSE  
The purpose of this association shall be to advocate and support an adequate, effective, and efficient air force, army, and navy, at all times; to perpetuate the friendships and memories of our service together in the 2nd Air Division, 8th Air Force, in England; and to undertake such other activities as may from time to time be deemed appropriate by the membership.
- III. MEMBERSHIP  
The membership shall consist of all personnel, military and civilian, British or American, who at any time served with the Headquarters organization of 2nd Bomb Wing, 2nd Bomb Division, or 2nd Air Division, at either Horsham St. Faith or Ketteringham during World War II. Any person who served with any unit of the 2nd Air Division, either assigned or attached, and expresses a desire to become a member of the Second Air Division Association shall be eligible for membership. An active member is a dues-paying member. Dues shall be \$2.00 per annum. All members who shall pay dues for 1949 through 1953, in the amount of \$10.00, prior to 31 October 1950 shall be Charter Members.
- IV. OFFICERS  
The officers of this association shall be a permanent honorary president, a president, four vice presidents, a secretary, and a treasurer. These officers shall be elected by the active members present and voting at the annual meeting, to serve for one year or until otherwise relieved.
- V. MEETINGS  
It shall be the intention of this association to have one regular meeting per year at a time and place to be determined by the executive board. A quorum shall consist of all active members present and voting.
- VI. EXECUTIVE BOARD  
The executive board shall consist of the duly elected officers and such other individuals as the president may appoint.
- VII. COMMITTEES  
The committees of this association shall be the following, appointed by the president:

- VIII. PARLIAMENTARY PROCEDURE  
Roberts' RULES OF ORDER shall be the governing authority in all proceedings of this organization except as otherwise provided by the constitution and by-laws.
- IX. METHOD OF AMENDING THE BY-LAWS  
The by-laws shall be amended by a two thirds majority vote of those active members present and voting at any meeting provided for by Section V. These by-laws shall become effective when adopted by two thirds of those active members present and voting at the annual meeting in October 1949.
