Dear Gang:

Even though it seems ages ago, this is our first report to you on the Reunion, held on August 16, 17, and 18 at Hershey, Pennsylvania. We were sorry more of you weren't there. Those who were had a fine time, and we expect to see you all next year.

We did accomplish some business between gab fests, golf games, cocktail parties and the banquet. We received, among other things, two bits of good news. The scroll will be in loose-leaf form for 10 years, after which it will be bound.
